

Cumberland County Awarded Federal Funds Under Phase 39 & Phase ARPA-R of the Emergency Food and Shelter Program

Cumberland County has been awarded \$124,180 under Phase 39 and \$383,811 under Phase ARPAR (American Rescue Plan Act-Regular EFSP). These funds appropriated by Congress are to supplement and expand existing emergency food and shelter programs in Cumberland County and to respond to the continuing COVID-19 impact on communities. Local Recipient Organizations use EFSP funds for mass shelter, mass feeding, food distribution through food pantries, food banks and food vouchers, pass due utility payments to prevent service disconnections, past due rent/mortgage assistance to prevent evictions and to assist people that are leaving shelters with establishing stable living conditions. Residents in need of assistance must contact the agency directly to check for availability of funds.

The Emergency Food & Shelter Program is a Federal program administered by the U.S Department of Homeland Security's Federal Emergency Management Agency (DHS/FEMA). It has been entrusted through the McKinney-Ventro Homeless Assistance Act (PL 100-77) "to supplement and expand ongoing efforts to provide shelter, food and supportive services" by local social service organizations for people across our Nation who are hungry, homeless, and in economic crisis. The EFSP National Board designated United Way of Cumberland County to serve as the administrator to the Local EFSP Board. Representatives from the following organizations are mandated to comprise the Local EFSP Board: American Red Cross; Catholic Charities USA; The Jewish Federations of North America; National Council of Churches of Christ in the USA; The Salvation Army; United Way of Cumberland County; Homeless or formerly homeless Agency/Representative; Native American Agency Representative; Government Agency Representative; and Council on Aging Agency Representative.
